NOTE: In addition to the topics covered in this program, each employer is responsible for the site-specific training of any new hire or employee. See Employer Responsibilities below.

TESTING & DEMONSTRATIONS

Final Exam (25 Questions)

All participants are required to demonstrate and perform a pole top, bucket and enclosed/confined space rescue.

NOTE: Only individuals qualified to climb will perform a pole top rescue.

EMPLOYER RESPONSIBILITIES

While this program provides awareness and general safety training required for and to begin employment, the employer is still responsible for providing tool, equipment, and site-specific training for each employee. Employer-specific training includes but is not limited to: site-specific Safety Data Sheets, written emergency action plans, tool-specific training, use of job-specific PPE including harnesses, bucket trucks and/or rescue equipment, etc.

NOTE: Only qualified employees may work on or with exposed energized lines or parts of equipment.
